NATA Super Singer 2020 - Participant Rules

NATA Super Singer 2020 Singing Competition comprises of three levels as follows.

1. Round 1: Audition (Recorded video songs due by **June 15th, 2020**)
2. Round 2: Virtual Event: Live on TV/Social Media (**June 26th, 27th & 28th, 2020**)
3. Finals : Virtual Event: Live on TV/Social Media (**July 4th, 2020**)

General Rules

- This competition will be streamed in Social Media and TV and participant should not have any objection to appear in Social Media or TV.
- Participant must be North American Resident only (Proof of address will be verified).
- Participants are suggested to take NATA Membership if you are already not a member. Please note that NATA Membership is family membership and if the parent is a NATA Member, kids under 21 are also considered as NATA Members. If Participant's family does not have a NATA membership currently, you can take membership instantly online (<https://www.nataus.org/user/register>).
- Judgement by Judge is final and participant must respect the decision and cannot discuss/discredit these judgement decisions in any form (email, social media, WhatsApp, Facebook, etc)
- You agree that NATA, TV partners, Social Media partners, Judges or its affiliates, will not be held liable for any reason to you or to any third party for any such herein or by law.
- Family members of the person (including himself/herself) who is in NATA Super Singer 2020 Committee cannot participate in the competitions.
- Previous NATA Idol winners are not also eligible to participate in this contest.
- Participants can choose any song from any Movie as long as the song meets the below criteria.
 - The song must be in the Telugu Language.
 - Length of the recording should not exceed 5 minutes.
 - Lyrics should not be indecent or obscene.
 - Lyrics should not be promoting any kind of hate against anyone.
 - The song must have been used in the movie (released officially).

Rules for Audition (Round 1)

- No fee for Audition, It's FREE!!
- Participant must be in the age group of 12-50 years as of July 04, 2020. Proof of age will be asked during Audition Round.
- A participant can record the song using any device, but the recording should be clear, and lyrics should be audible. The poor recording may disqualify the entry.
- Singer face & head must be clearly visible in the video while singing the song for the audition.
- Participant should upload the video to YouTube with following Title and give us the link
NATA Super Singer 2020 – Audition <First Name> <Last Name>
- Karaoke tracks should NOT be used for Audition submissions.
- Well-Known judge will screen all entries.
- About 30 participants will advance to the Round 2.
- Participants who advanced to the Round 2 will be informed through email.
- Participant cannot have any direct communication with the judge. Trying to communicate with the judge by any media can lead to disqualifying the participant from advancement to the next level.
- NATA has right to share these videos on Social Media and TV.

Rules for Round 2

- No fee for Round 2, It's FREE!!
- Up to 30 singers will participate in Round 2.

NATA Super Singer 2020 - Participant Rules

- Round 2 will be conducted Online on June 26th, 27th, 28th, 2020 with 10 singers each day. If there is a change to this date in case of unavoidable circumstances, that will be communicated as early as possible.
- The song must have the background Karaoke. The Karaoke track must be clear from the noise and should not have any vocal part in it, even if it is of opposite gender's.
- Participants selected for Round 2 will be asked to submit the Karaoke tracks via email.
- Karaoke tracks must be received at least four days before the competition.
- The participant should send the below details when sending the track.
 - First Few Words from the Song/Movie Name/Lyricist/Music Director/ Singers Names
- The participant must attend Round 2 virtual online on the published date. Failure to do so will automatically disqualify the participant.
- A well-known judge will select the winners. Judge has all the rights to select the qualified participants for the Finals.
- Round 2 will be conducted virtual online and winners will be announced at the end of Round 2 on NATA website/Social Media and will be informed through email.
- Round 2 Winners will advance to the Finals that will be conducted online.
- For better quality of online video, singers are suggested to connect laptop to Ethernet Cable instead of WiFi.
- It is participant responsibility to keep the surroundings quiet and mute all the TV/Phone and no one is near and in the video frame.
- If our Technical team hears any external noise and if it is a disturbance to live audience, your line will be muted and/or not displayed even if you are singing live and participating.
- Please note that you will have disadvantage if the audio quality is bad because of the Network issues or if your line had to be muted because of the external noise. It is completely your responsibility.

Rules for Finals & Other Guidelines

- No fee for Finals, It's FREE!!
- 6 singers will participate in Finals.
- Finals will be conducted Online on 4th July, 2020. If there is a change to this date in case of unavoidable circumstances, that will be communicated as early as possible.
- The song must have the background Karaoke. The Karaoke track must be clear from the noise and should not have any vocal part in it, even if it is of opposite gender's.
- Participants selected for Finals will be asked to submit the Karaoke tracks via email.
- Karaoke tracks must be received at least 4 days before the competition.
- The participant should send the below details when sending the track.
 - First Few Words from the Song/Movie Name/Lyricist/Music Director/Singers Names
- The participant must attend Finals Online on the published date. Failure to do so will automatically disqualify the participant.
